1. Wherever the word, "Odisha" appears, it may be read as "Orissa".
2. In part-2, instruction to the tenderers at page 5, in point 11 the word "Documents" appearing in the 3<sup>rd</sup> line be read as "Documents".
3. In part-4, General Terms and Conditions at page 10, point 4 the words "and 2D/3D conventional, both" be added after the words "6000 DPI or above" appearing in the 2<sup>nd</sup> line.
4. In Tender Form and Price schedule, at page 17, the words "per Holograms" appearing under the item to be supplied be replaced by "per 1000 Holograms".
