NOTIFICATION

Whereas in exercise of the powers conferred by the proviso to sub-section (3) of section 89 of the Bihar and Orissa Excise Act, 1915 (Bihar and Orissa Act 2 of 1915), it is considered by the State Government that the following rules made under section 89 of the said Act shall be brought into force at-once.

Now, therefore, in exercise of the powers conferred by section 89 of the said Act, the State Government do hereby make the following rules further to amend the Orissa Excise (Exclusive Privilege) Foreign Liquor Rules, 1989, namely:-

1. (1) These rules may be called the Orissa Excise (Exclusive Privilege) Foreign liquor Amendment Rules, 2006.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Orissa Excise (Exclusive Privilege) Foreign Liquor Rules, 1989 hereinafter referred to as the said rules), in rule 3, for sub-rule (1), the following sub-rule shall be substituted, namely :-

"(1) A public notice shall be issued by the Collector on behalf of the State Government in Form and in the manner specified hereinafter, before granting any exclusive privilege to one person for retail sale of foreign liquor giving 15 days time there in for receiving objections."

3. In the said rules, to rule 4, the following proviso shall be added, namely:-

"Provided that any objection received beyond the stipulated period given in the Public Notice as provided under sub-rule (1) shall not be considered by the State Government."
