Excise Fee, Excise Duty & Margin Structure along with Regulatory Sub: Guidelines for the remaining period (01.08.2019 to 31.03.2020) of the year 2019-20.

Sir,

I am directed to invite a reference to the subject cited above and to say that Government, after careful consideration, have been pleased to order that the Excise Fee, Excise Duty & Margin Structure along with Regulatory Guidelines for the year 2019-20 issued vide this Department letter No.1161 dtd 07.03.2019 for the 4 (four) months i.e upto 31.07.2019 shall continue till 31.03.2020 with the following modifications:-

- 1. At Clause 4.2.1 (i) the existing provision "All F.L OFF as well as ON licensees "may be substituted by "All F.L OFF as well as ON licensees except beer parlour ON licensees".
- 2. At Clause 4.2.8 it may be reiterated here that advance consideration money of 3 (three) months for the existing IMFL OFF/CL/Out-Still/Tari/Pochwai and Bhang licensees shall be collected by 31.7.2019 from those E.P holders who have applied for renewal of their licenses. No license shall be issued if this is not complied with. In addition to above advance consideration money, each licensee must pay one time interest free security deposit equivalent to one month consideration money in case of renewal of their licenses.
