In partial modification of this Department letter No. 1067 dated 03.03.2015 and in continuation to this Department Corrigendum No. 2735 dated 13.05.2015, new Excise Policy (Excise Duty, Fee Structure and Guidelines) for the year 2015-16, the following clauses have been amended in the following manner.

1. Clause 2.4.4 is amended and the same may be read as follows:

**"Annual license fee for Hotels and Restaurants without lodging Rs. 8.5 lakhs".**

2. Clause 4.2.2 (c) is amended and the same may be read as follows:

**"the license fee of "ON" shop to be realized in four equal installments".**

3. Clause 3.3(d) is amended and the same may be read as follows:

**"the wholesaler profit margin of all excise items to be 1%"**
