
Sl No.	Name of the post	Scale of Pay with Grade Pay	Number of posts created

03	Assistant Sub-Inspector of Excise	Rs.5,200 - Rs.20,200/- + Grade Pay Rs.2,000/-	114 (one hundred fourteen)
04	Excise Constable	Rs.4,440 - Rs. 7,440/- + Grade Pay Rs.1,650/-	71 (seventy one)




