Applications are invited from the interested retired OSS officers of the Secretariat in the rank of Section Officers, Desk Officers, Under Secretaries and Deputy Secretaries, not above the age of 62 years and having good service records and physical fitness for appointment as "**Officer on Special Duty**" on contractual basis in Excise Department, against the vacant post of ASO in pursuance of Home Department Resolution No.42595 dt. 10.10.2011 under the following terms and conditions:-

1. The Contractual engagement will be made for a period of one year and that can be extended by further period of one year subject to satisfactory performance and shall not be extended beyond attaining the age of 62 years.

2. The retired Officer, against whom a vigilance case or departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to ten years preceding his/her retirement, or is a member of a political party will not be considered for re-engagement.

3. Consolidated remuneration of the contractual employee shall be at the rate of his/her last Pay + Grade Pay drawn minus the amount of pension sanctioned per month subject to maximum of Rs. 10,000/- (Rupees Ten thousand) only per month.

4. The period of contractual engagement shall not be counted as Government service for the purpose of pension and any other retirement benefit.

5. The appointee has to discharge the duties as prescribed by this Department from time to time.

6. Performance of the appointee shall be monitored rigorously by the Department against the monthly targets assigned to him.

7. The contractual engagement may be terminated at any time by the Department for unsatisfactory performance, on notice of one month and in case of any misconduct including, but not limited to misappropriation, negligence or causing loss to Government without any prior notice.

8. After expiry of the engagement period, the officer may be relieved after being handing over full charges of records to the relieving officer as decided by the Department.

9. The engaged officers will be subject to & will abide by the Conduct Rules applicable to the Government Servants.

10. Applicants who have already applied for engagement as OSD in Excise Department need not apply again.

11. The appointee will furnish an undertaking at the time of joining the duty as regards to truth and correctness of the information furnished by him/her.

12. **The interested OSS cadre retired officers fulfilling the above criteria may apply within 15 days from the date of issue of the Advertisement and application with all information of the applicant along with full bio-data and history of service records in the Secretariat should be addressed to the Principal Secretary to Government, Excise Department and same should be reached to the Department within the time frame.**
