**IIEx-180/2021 (EXC-POL-POL-0187-2021)**

In the new Excise Policy (Excise Fee, Excise Duty and Margin Structure along with Regulatory Guidelines) for the year 2022-23 communicated vide Excise Department letter No. 1393 dated 28.03.2022, the following two items are hereby modified.

1. IMFL Labels / Brands with Offer Price per standard case mentioned at Clause 2.5.1 (B) may be read as ₹ 2000/- to ₹ 5000/- instead of  $\geq$  ₹ 2000/-.
2. The strength of CL mentioned at Clause 4.2.4(I) & (II) may be read as 40° UP /50° UP /60° UP and other ENA based CL of 50° UP /60° UP strength instead of strength 400 UP/500 UP/600 UP and other ENA based CL of 500 UP /600 UP strength.
