ANNUAL ACTIVITIES REPORT OF THE EXCISE DEPARTMENT FOR THE YEAR 2022-23


1. Excise Department was set up as an independent Department with effect from 01.12.1999 after being carved out of the erstwhile Revenue and Excise Department. It is a resource generation Department of the State. It enforces the State Excise laws and the NDPS Act.1985 in the State.

2. EXCISE REVENUE:

- 2.1 Excise Department regulates the manufacture, import, export, transport, storage and sale of excise goods. The endeavor of the Government has been to ensure that the existing demand is met by legitimate and safe supply of liquor, which is fit for human consumption. Any short supply of legitimate liquor is bound to result in bootlegging / spurious liquor filing up the gap, which would endanger public safety.
- 2.2 According to Article 246 (3) of the Constitution of India, the Legislature of the State has exclusive powers to make laws for the State or any part thereof with respect to any of the matters enumerated in list II of the Seventh Schedule of the Constitution. Item No. 8 of the List II envisages intoxicating liquors, that is to say, the production, manufacture, possession, transport, purchase and sale of intoxicating liquors. Item No. 66 of the List II of the Constitution empowers the State Legislature to impose fees in respect of any of the matter enumerated in this list. The excise duty is leviable in respect of alcoholic liquors for human consumption manufactured in the State or produced elsewhere in India (item No. 51 List II. 7th Schedule).
- 2.3 The State has exclusive right to grant privilege for manufacture, possession and sale of intoxicating liquor. However, the State grants such privileges to persons in shape of licenses.
- 2.4 The monopoly in wholesale trade in liquor in the State is vested with Government and it operates through a Corporation under the name and style of 'Odisha State Beverages Corporation' (OSBC). An intoxicant can be manufactured or imported as per the provisions of the relevant Act and Rules but the same cannot be sold to any business unit except through the Odisha State Beverages Corporation. Hence the entire saleable quantity of intoxicants is acquired by the Beverages Corporation. The Corporation sells to the licensees under terms and condition prescribed by the Government as well as by the Corporation from time to time.

2.5 The Excise Revenue has increased over the years. The figures for the last ten years are as follows: -

3. IMFL AND BEER

- 3.1 The main source of Excise Revenue in the State is through imposition of duty on India Made Foreign Liquor (IMFL) and Beer. There are 1163 Foreign Liquor 'OFF' shops, 702 'ON' shops, 19 'ON' Clubs, 56 Beer Parlour, 36 Military Canteen in the State for the year 2022-23.
- 3.2 Consideration money is collected from the IMFL 'OFF' / 'ON' / Beer Parlour and Club 'ON' shops each month. Besides, the State gets duty on the IMFL and Beer lifted by the retailers. The retailers have to lift a Minimum Guaranteed Quantity (MGQ) of IMFL and Beer, which ensures a guaranteed amount of duty.

4. OUT STILL (OS) LIQUOR:

Twenty Two Excise districts of the State namely Sambalpur, Bargarh, Jharsuguda, Deogarh, Kalahandi, Nuapada, Bolangir, Sonepur, Boudh, Koraput, Rayagada, Nabarangpur, Malkangiri, Sundargarh, Angul, Keonjhar, Mayurbhanja, Ganjam, Gajapati, Dhenkanal, Berhampur and Rourkela are having Out Still system. These Out Still shops are settled by lottery. There are 551 Nos. of Out Still shops with 1465 branch shops for the year, 2022-23.

5. COUNTRY LIQUOR SHOPS:

5.1 Country Liquor shops are prevalent in 10 Districts namely Cuttack, Jagatsinghpur, Bhubaneswar, Kendrapara, Jajpur, Puri, Nayagarh, Khurda, Balasore, and Bhadrak. There are 242 nos. of Country Liquor shops in the State for the year 2022-23.



LIFTING OF IMFL AND BEER





8. PERFORMANCE OF ODISHA STATE BEVERAGES CORPORATION:

8.1 Government have taken over the monopoly in wholesale trade of IMFL and Country Spirit through a State owned Corporation namely, Odisha State Beverages Corporation Ltd., which has been incorporated as a wholly owned company of the State Government under the Companies Act, 1956. As a result, the collection of Excise duty and sales tax has been increased. A year-wise growth chart of excise duty and sales tax for last ten years is given below: -

8.2 The Corporation has an authorized capital of Rs. 5.00 Crores. The Government have subscribed Rs. 1.00 Crore towards equity to the Corporation. The Corporation has opened its depots at Khurda, Cuttack, Berhampur, Sambalpur, Balasore, Angul, Rayagada, Jajpur&Sonepur. The Corporation has also opened Country liquor depots at Cuttack, Khurda, Balasore and Jajpur which cover 09 Districts namely Cuttack, Jagatsingpur, Kendrapara, Jajpur, Puri, Nayagarh, Khurda, Balasore, and Bhadrak.


9. ENFORCEMENT

9.1 There are four Excise Intelligence and Enforcement Bureau (E.I. & E.B) Units in the State for effective control of Organized Excise & Narco related crimes and to protect the Revenue interest of the State. Out of these 4(four) units, 1(one) unit each is under the control of the 3(three) Excise Deputy Commissioners and 1(one) unit is under the direct control of Excise Commissioner, Odisha. Besides 3(three) Satellite units of Excise Intelligence and Enforcement Bureau (E.I. & E.B) have been created this year at Balasore, Rourkela and Jeypore under jurisdiction of Revenue District of Balasore, Rourkela and Koraput respectively. In addition to these EI and EB Units, there are mobile units in the districts to ensure enforcement.

10. DETECTION AND DESTRUCTION OF HEMP PLANT

During the year 2022-23, Rs.70.00 Lakh has been provided for strengthening enforcement activities to 9(nine) districts namely Angul, Berhampur, Boudh, Gajapati, Ganjam, Kandhamal, Koraput, Malkangiri and Rayagada where there is high density of hemp plant cultivation.

11. STEPS TO CHECK ILLICIT LIQUOR

- **11.1** In order to prevent the illegal inflow of non-duty paid liquor, Excise Adhesive Labels are affixed to distinguish duty paid liquor. Such labels are being affixed on each bottle of IMFL, Beer and Country liquor bottle.
- **11.2** To prevent and check the flow of illicit liquor, 3(three) Excise Divisional Offices are functioning in the State along with 33(thirty three) Multi-Disciplinary Squad, 33(thirty three) District Mobile teams, 71(seventy one) Excise Range Office, 201(two hundred one) Excise Stations under 33(thirty three) Excise Districts. One Enforcement Cell has been set up in the Excise Directorate with engagement of one DSE to monitor the activities on daily basis through online module in eABKARI web portal.
- **11.3** Public Awareness has been made involving N.G.O.s , S.H.G.s and Panchayati Raj Institutions about the dangers of drinking, particularly I.D. and spurious liquor. Besides, to gather information about illicit liquor traders, one toll free Helpline No. 1800-3456-713 has been introduced and the same is functioning in the Office of Excise Commissioner, Odisha, Cuttack. For observance of International day against Drug Abuse & Illicit Trafficking in districts, Rs.7.60 lakh has been provided to districts in 2022-23.

- **11.4** The excise cadre has been restructured raising the total strength from 2215 to 2672 with creation of 9 new Excise Station, 13 Excise Range Offices and 3 Satellite Units of Excise Intelligence & Enforcement Bureau. For mobility support, 54 additional vehicles have been provided.
- **11.5** Proper co-ordination with Police, NCB and other enforcement agencies are being made to strengthen the enforcement activities in the State.
- **11.6** Government have empowered the Excise officers above the rank of Constable of Excise under section 83 (2) to investigate any offence or for all offences punishable under the Odisha Excise Act, 2008.

Total 32.512 Kgs of Brown Sugar and 41330.102 Kgs of Ganja have been seized under NDPS Act during the financial year 2022-23.

More concerted efforts are being made for training of the excise field functionaries so as to achieve better coordination with all related agencies and to ensure that the conviction rate in excise offences goes up significantly.

13. STAFF STRENGTH:

There is only one Directorate under the Administrative control of Excise Department headed by the Excise Commissioner. There are three Excise Deputy Commissioners for Central Division, Cuttack, Southern Division, Berhampur and Northern Division, Sambalpur.

13.3 Training

It has been decided to train the excise personnel from the rank of Excise Constable to the rank of Deputy Superintendent of Excise & the training shall be held in phased manner in different police training institutes. The detail training module/ schedule for different excise personnel have been furnished to the ADG of police (Training) BPSPA (Biju Patnaik State Police Academy). An amount of Rs.10.00 (ten) lakh has also been placed with the BPSPA for the purpose.

14. HR Restructuring

The cadres of Odisha Excise Service, District Excise Ministerial Service and Excise Directorate Service have been restructured by creating 487 additional posts at different levels. In addition to this, 9 new Excise Stations, 13 new Excise Range offices, 3 new Satellite units of EI & EB Units under Excise Department have also been created.

15. Civil Infrastructure

• For strengthening Excise Administration and addressing its infrastructure requirements, Excise Department has been undertaking construction work since 2012 through two executing agencies- Chief Engineer (Buildings), R&B, Odisha under Works Department and Chief Engineer (Buildings & Bridges) RW, Odisha under Rural Development Department.

- To further expedite the civil construction work and for optimal use of budgetary allocation, the Odisha State Police Housing and Welfare Corporation Limited (OSPH&WC), has been roped in from last year, in addition to the above two executing agencies for development of Excise infrastructure in the State.
- During the Financial year 2022-23, taking into account the number of continuing projects and new projects sanctioned, Rs 40.00 Crore has been provisioned under Programme Expenditure. 34 (Thirty four) number of New projects / renovation work have been sanctioned for construction of Excise Stations / Range Offices / District Excise Offices including residential buildings.

Construction of Excise Bhawan.

GA & PG Department has allotted 2.00 acres of Govt. land in Mouza - Chandrasekharpur, Khata No.619(GAD), Plot No.457 (Pt), Kissam-Gochar vide their Order No.4210/CA dated 17.02.2023 for construction of administrative building of different excise offices wherein the Excise Department, Excise Directorate, EAL Godown, State Flying Squad, State Chemical Testing Laboratory, Training Academy, Library etc. shall function. The Odisha Police Housing and Welfare Corporation (OPH & WC) has been selected as Executing Agency for the purpose.

16. Uniform:

- Ideal uniform for the Odisha Excise Personnel from the rank of Excise Constable to the rank of Additional Commissioner of Excise with Distinctive Insignia Shoulder Badge as per the rank & functional designation and procedures for wearing uniform by the officers along with uniform for Excise Drivers have been introduced to bring a sense of responsibility and cohesiveness among the excise personnel.
- Uniform allowance in lieu of uniform for excise personnel from the rank of Excise Constable to the rank of Additional Commissioner of Excise including Excise Driver have been introduced.

17. Provision of vehicle:

• Approval of Finance Department have been obtained to hire (a) 1 (one) vehicle for the office of Excise Commissioner, Odisha; (b) 4 (four) vehicles for four EI & EB Units @ one each and (c) 49 (forty-nine) vehicles for 13 newly created Range Offices, 3 new Satellite Units of three Divisional Offices and 33 newly proposed model Excise Stations.

18. NDPS Godown:

• 10(ten) Nos. of NPDS godowns have already been constructed and made operational at Angul, Mayurbhanj at Baripada, Sambalpur, Bargarh, Boudh, Ganjam at Chatrapur, Koraput at Jeypore, Cuttack, Puri and Khordha for storage of seized NDPS controlled substances with double locking system, provision of CCTV surveillance and round the clock guarding by the Security personnel in compliance to the order dated 28.1.2016 of the Hon'ble Supreme Court of India passed in Criminal Appeal Case No.652 of 2012 (Union of India- vrs- Mohanlal and another).
