Sealed Tenders in plain paper/ letter pad are invited from the intending registered Firms in Odisha having valid GST registration number/ Income Tax Clearance Certificate/ PAN card for supply of 03 (three) Nos. of **Godrej Make Heavy Duty Rack of Width-2700 mm, Depth-600mm, Height-2500mm, Loading Level-04 Nos., Load/Level-300 kg udl/level** for Record Rooms of this Department located in the office building of the Directorate of Mines & Geology (Geology Wing) at Unit-V, Bhubaneswar. Intending suppliers, if so required, may visit the Record Room at 5th floor of the said office building.

The Tenderers shall furnish an undertaking to the effect that their firm has not been black listed in the past by the State Government.

The Tenders should reach the undersigned by 16.12.2023 (4.00 PM) and the Tenders shall be opened on 18.12.2023 at 5.00 PM in the presence of Purchase Committee of Steel & Mines Department and in the presence of Tenderers or their representatives in the office chamber of Special Secretary to Govt., Steel & Mines Department, 3rd Floor, South Annex Building, Lokseva Bhawan, Bhubaneswar.

The approved/ accepted Tenderer shall only deliver the materials at the record rooms located in 5th Floor in the office building of the Directorate of Mines & Geology (Geology Wing) at Unit-V, Bhubaneswar on receipt of orders. No other option or point of delivery of the material shall be taken into consideration.

The approved/ accepted Tender will remain valid for a period of 01 year from the date of acceptance or as would be decided by the competent authority.

The selection of Tender shall be made on least cost methodology.

1. The approved Tenderer should deposit 2% of the total value of the goods to be supplied towards EMD. Such deposit shall be retained as performance security which shall be returned after expiry of the warranty period
2. The tenderer must specify warranty details for consideration of their tender.
