"The Medical Officers who are continuing their PG study / Superspecialisation course in any institution and Senior Resident / contractual Assistant Professor only in Government Medical Colleges of the State are selected for regular appointment on the recommendation of the OPSC may be allowed to join at the place of their posting in the periphery and may be relieved by the concerned CDM & PHO on the next day in order to enable them to continue their PG study, Superspecialisation, Senior Resident ship or contractual Assistant Professor in the respective Medical Colleges on submission of an undertaking to join and serve under the State Government at the place of posting on completion of their higher studies."

All other contents of the aforesaid notification shall remain unchanged.
